Feedback Obtained

The University had informal methods of getting feedback from the students, old students and teachers at the beginning of the establishment. Recently the University has designed formal questionnaires containing the relevance of programs, possibility of getting employment, teacher's expertise on the subject, availability of ICT facilities as well as existence of infrastructure facilities such as separate rest rooms for women and so on. Besides, questions on library such as collection of books and journals have been addressed here. Students and other stakeholders were asked to give their rating on the above indicators using 4 point Rector Scale. Data collected has been processed and teachers who got below 50 percent of score were called for counselling and consequently, remedial measures were taken.

As a stress relief measure, the mentors are expected to guide and support the students for the participation in all the academic activities. • Encouraging the students in reading reference books. • Conducting meetings with personalities who have the distinctions. • Developing skills to face the examinations instead of facing unwanted tensions during the examination. • Encouraging them to reach academic target. • Counselling for the particular student who is facing stress whether it is personal or academic. Councillors are expected to suggest them to overcome from the stress. • Suggesting them to actively participate in the sports, cultural activities so that they can reduce the mental stress. • Suggesting them to interact with the society by doing social works and other activities. • Informing them about their role and responsibility in the society. • Suggesting the students to take the competitive examinations and placements. • One skill development officer and one psychologist will be associated to counsel the students on all the above mentioned topics.
