# **Rules for M.Phil. Study**

#### 1. Eligibility for M.Phil. Course

- 1.1. Student should have scored 55% marks in 2 years post graduation from any UGC recognized university. But Students of SC/ST and Group-1 Category should score 50% in post graduation will be eligible for study.
- 1.2. The lecturers who are appointed in government aided and post graduation degree college/university and lectures in permanent service who scored 50% in related subject in post graduation are eligible for M.Phil. Study. According to U.G.C. rules student has to be present compulsorily for one year to study classes conducted by university.
- 1.3. There is no necessity of entrance exam for students passing UGC/CSIR/NET/SLET/GATE/JRF/ or FIP/QIP entrance exam. There is an exemption for students who are selected under special grant plans and are working and also for government sponsored foreign students. Committee of department can refer (recommend) for registration after conducting oral exam and examining the results.
- 1.4. The students getting eligibility as per the rules of a and has to attend the entrance exam conducted by university for selection.
- 1.5. The candidates working in government offices or in any institutions have to compulsorily submit no objection certificate from the concerned institution.

#### 2. Call for Application

- Regarding M.Phil. study publication, systematic prior preparation has to be done. Entrance process is announced in medias through advertisements. It is announced through UGC website. Seats for each department for an year will also be announced.
- 2.2. Every years students has to collect the application by paying the fees fixed by the university. Application will also be available in the website. The application sownloaded can be submitted through fees D.D. this will be the application of entrance.
- This entrance exam will be a test about the subjects studied in M.A., Knowledge on M.Phil. Selected topics, language, style, etc. This paper carries 100 marks. Written (80 marks) and interview (20 marks), students has to score 50% in entrance and 50% in post graduation and average will be considered. Based on this selection list will be prepared.
- The valuation of the answer papers will be done in the department. On the same day of entrance examination the department committee will conduct an interview for students. Select list of students and submit to study centre.
- 2.5. Student has to appear for entrance exam on their own expenditure.
- Entrance exam and interview is compulsory for students. There will be an exemption for students passing UGC/CSIR/NET/SLET/GET/JRF or FIP/QIP. These all points are applicable to M.Phil. degree entrance examination.
- During M.Phil. degree entrance process the state government reservation policy has to be 2.7. strictly followed.

### 3. Entrance Exam/Interview

- 3.1. As per UGC rules, students are selected for M.Phil. Study, through entrance exam and interview.
- 3.2. There is on opportunity for revaluation and re-examining the papers after the announcement of entrance examination list. The list of students passed in entrance exam will be announced

- through <u>www.kannadauniversity.org</u> website. Separate entrance letters will not be sent to the candidates.
- 3.3. The eligibility list of registered centre candidates will be announced with the centre of examination for writing.
- 3.4. The selection list will be announced through website. The candidates interested to get admission for courses have to pay the necessary fees within the final date in study centre. The candidates of recognized institution can get admission in recognized institutions and extension centre candidates in extension centre can get admissions.
- 3.5. The application submitted cannot be transfused to any departments, extension centre and recognized institutions.
- 3.6. Whatever may be the post graduation subject of the candidates, the subject opted by student for study will be mentioned in the marks card, study certificate and once the result of M.Phil? Entrance selection is announced there is no provision for re-valuation and re-examination.

Excluding the fees with fine for SC/ST and group-1 category candidates there will be 50% concession for all fees. The fee structure will be based on the decision of university.

## 5. Subject of Study

- 5.1. The selection of topic for research by students must be related to art, literature, history, culture, language, translation, society, and development etc of Karnataka. The subject (topic) must be related to Karnataka and a comparative analysis with another subject can be done.
- 5.2. Each department of the university has to prepare the list of important topics based on the possibility of conducting research by selecting the field.
- 5.3. At the period of calling the application for M.Phil. research degree, has to display the important topics on the notice board of seated department and in the website of Kannada university. But this may not be the finalized topics.
- 5.4. The University will give provision for the study if the topic selected by student and guide is desirable (Precise). The department of the university refers preferable field than the topic of subject. Based on the possibility of research and preferable fields, there will be an opportunity for extension of study by supervisors and students.

Though the Student had completed post graduation in any subject, the subject for M.Phil. study admission will be mentioned in M.Phil. marks card, affidavit and notice.

## 6. Registration

- 6.1. Students selected in entrance examination have to pay the registration fees and get the admission confirmed and has to pay annual education fees to the university.
- 6.2. Student selected for study, has to select the guide and M.Phil. dissertation title has to be kept with allusion for registration.

## 7. M.Phil. Study Committee

7.1. Following M.Phil. Study Committee is as follows according to particular faculty/department.

3. Head of Department Member – Co-ordinator

In Case of absence of Dean of Faculty, the head of department will be the President of committee.

- 7.2. The responsibilities of M.Phil. Study Committee
  - 7.2.1. Participation in M.Phil. entrance exam process.
  - 7.2.2. Within the 6 months of M.Phil registration, the specific title and M.Phil. study research limit and name of supervisors has to be confirmed. The Committee with members of department has to re-examine the subject and has to official it.
  - 7.2.3. Permission will be given for change of supervisors and department if the reason is precise.
  - 7.2.4. Recommendation to supervisors for approval.
  - 7.2.5. It the guide recommends for change of title, it will be examined and permission would be granted.
  - 7.2.6. Executing the responsibility thrusted by the university regarding M.Phil. Study.

## 8. Period of Study

- 8.1. M.Phil. Study is ten months course. The first four months is reserved for teaching work. Next 6 months will be devoted for preparation of dissertation of M.Phil. Study. It is necessary to have computer knowledge by student during the period of course. Till the completion of course student has to be present compulsorily present in the related department. 80% attendance is compulsory for each subject. Maximum 30 days is allotted for field work. Pre-permission should be taken for field work after written examination.
- 8.2. Study method: 5 papers will be there in the syllabus. Each paper carries 100 marks. For the first four papers written examination will be conducted for 80 marks and 20 marks for internal assessment. 5<sup>th</sup> paper will be related to dissertation work of M.Phil. study. Dissertation of study carries 100 marks. The answers papers has to be corrected from internal and external evaluators. In any theory papers if there is difference of 16 and more than 16 marks from internal and external evaluates, third valuation has to be done from third evaluator. This will be the final valuation.
- 8.3. 50% marks has to be scored in each papers. 55% average marks has to be scored. If the student fails in any papers including dissertation, maximum3 marks can be given as grace marks. These marks can be taken from other papers in which student have scored excess marks. One (1) grace mark can be given for passing if he fails in any papers. This grace mark facility is applicable to the candidates who have appeared first time to exam and submitted dissertation for the first time. It the student is failed has to write re-examination in the failed papers within a month. Even then if a student fails in re-examination, will not be allowed to present dissertation. They will be out from M.Phil. study. If a student fails to appear for examination even after paying examination fees due to uncertainties will not have provision for re-examination.

#### 9. Guide of M.Phil. Study

For the confirmation of guide for M.Phil. study certain norms has to be framed according to UGC rules.

## 9.1. Eligibility

- 9.1.1. The Professors of Kannada university, lectures with Ph.D. holders, 5 years teaching experience, permanent Ph.D. lecturers are eligible to become the supervisors for M.Phil. study. Ph.D. scholars who desires to be the guide has to continuously involve in research, teaching and publication. Vice chancellor will have the authority to decide the guide in special occasions.
- 9.1.2. During the occasion of excess applications for M.Phil. Study, the department can invite the professors of other department as guide who doesn't have M.Phil. students. So the professors of other department can be considered as guide for this department. But there is no provision for extra seats than the seats confirmed. Head of department and dean of faculty has to decide reservation rules for M.Phil. Study. At the period of deciding the

subject of student and guide, dean of faculty, director of study center and head of department has to decide with discussions.

#### 10. Subject and Distribution of Candidates

- 10.1. There is provision for admission to students in Kannada university if there are availability of professors and supervisors in different departments. At the time of interview, the seats are distributed to students with the consent of subject experts according to the interested topics chosen by students
- 10.2. The supervisor of Kannada university has the provision of guiding for maximum 5 students of M.Phil. Two girls, one SC/ST, and one student should belong to backward class general category students number should not exceed 50%.

#### 11. M.Phil. Dissertation submission

- 11.1. It is a significant challenge for M.Phil. students to submit M.Phil. dissertation under the guidance of supervisors in specific time.
- 11.2. Students have to prepare draft copy of dissertation 2 months before the completion of study period. The draft has to be presented into the department committee members. The suggestion and advices has to be followed in the dissertation.
- 11.3. Five copies of dissertation in the form of D.T.P. have to be submitted to study center through head of department will the confirmation letter from supervisors. The final synopsis and M.Phil. Dissertation soft copy in the form of C.D. has to be compulsorily submitted to study center. It the supervisor belongs to other department but the student has to submit M.Phil. Dissertation to that department where he got registration.
- 11.4. If the student fails to submit dissertation in specific time due to inevitable circumstances will be provided with one time opportunity for submission in the following year. This will not refer further. Suitable reason has to be given for slow process.
- 11.5. **M.Phil. Dissertation Plan**: M.Phil. study dissertation would be in A4 model. Fonts should be in 14 point words and minimum 30 lines for each page. D.T.P. should be done in 23cm length and 13cm breadth. The matter should be in 60 to 80 pages. There must not be pages containing the matter of expressing gratitude, dedication the reference works, foot notes etc and complimentary annexure for study should be there. Index should be there next to the affidavit of student and supervisor. The submission of dissertation to the particular faculty of Kannada University has to be mentioned.

## Language Used for M.Phil. Dissertation

Student has to write M.Phil. dissertation in Kannada.

## 12. Evaluation of Study Dissertation

The evaluation of M.Phil. will be followed according to the system of central evaluation. Two evaluation has to be done for one dissertation from the professors of the department and from the member of examination board. After taleing the average of tow valuation marks is submitted to study centre.

#### 13. Subordination of study Dissertation

- 13.1. The soft copy of praxis M.Phil. degree study dissertation should be sent to U.G.C. within 30 days from study centre. Facility has to be done for its availability in INFLEBNET and UGC internet.
- 13.2. Right over M.Phil. study dissertation completely belong to Kannada university. During the process of publication, student has to take written permission from the university. During publication, every amendment has to be followed as referred by evaluators and submit it to study centre and has to take affidavit. Student has to be grateful to university. 6 copies has to be submitted to study centre after publication.
