Rules of B.Music Course

1. Admission:

- 1. Visual Arts Department: Three years degree in Music (B.Music Batular of music)
- 2. Degree Classes.
- 3. B.Music First year
- 4. B.Music Second year
- 5. B.Music Third year

2. Period

Three years degree course for the students who have completed 2 years P.U.C. in any stream.

3. Eligibility:

1. B.music first year

The candidates must have completed 2 years. P.U.C. or any equivalent course are eligible to get admission for the degree course.

2. B.Music Second year.

- a. The candidates passing first year B.Music are eligible to get admission for second year.
- b. The Students are provided with the opportunity for admission to second year B.Music even if he has failed in 4 subjects in first year B.Music.

3. B. Music final year (Third year):

The Students passed in second year B.music are eligible for admission to third year B.music. The Students failed with maximum 4 subjects in B.music second year are eligible for third year admission. In this context, have must be compulsory passed all subjects of B.music first year.

The result of B.music final year will be announced if the student had cleared (passed) all the subjects of B.music second year.

4. Admission Limit of students.

- a. The limit of students for admission of B.music is minimum 05 and maximum 10.
- b. The admission number of students will be fixed by the University with a change of period. If the admission exceeds the maximum limit, separate class will be started with the permission of the University.

5. Teaching Medium:

- a. The teaching of medium will be only in Kannada. In the circumstance of answering the papers in other language, it has to be entered in the examination application.
- b. For written examination there is a concession for blind students. Opportunity is provided to take the help of assistant for writing examination.

6. Eligibility for Teaching and Non-teaching staff.

- a. The teaching faculty must have compulsorily completed his post graduation in M.A. Music/M.music or any equivalent examination and must hold eligibility according to U.G.C Rules.
- b. Preference will be given for M.Phil and Ph.D. degree holders. The candidates of general merit must score maximum 55% in post graduation SC/ST and group-1 category candidates must score maximum 50% in post graduation. At the time of appointment of Professors, the U.G.C. norms and roster system should be followed.
- c. The Prescribed syllabus related subject professors holding the post graduation should be compulsorily appointed. It should be verified at the time of new appointments of assistant Professors.

7. Teaching period of Syllabus:

- a. Professor: Per week: 12 to 16 hours, Theory and practical Subject.
- b. Associate Professor: Per work: 12 to 16 hours. Theory and practical subject.
- c. Assistant Professor: per week: 12 to 16 hours. Theory and practical subject.

8. Attendance:

- 1. Generally the Academic period is 180 days and the student must hold 75% attendance in all subject and must hold attendance certificate. For 10% low attendance due to ill health and other reasons, should get the permission from University.
- 2. Pre-permission should be taken at the circumstance of participation in various cultural programmes, music, concerts, seminars etc. The Professors, accompanying the students to any programmes organized by any university or institutions, will be provided with leave on duty. Pre-permission is required.
- 3. The list of students holding the attendance below 75% should be sent to the University. Suitable reasons should be given to the university for 10% absence and must get permission.
- 4. The list of students with low attendance should be made, and must be brought to the notice of students and list must be displayed in the notice board before the examination process.
- 5. If the necessary and satisfactory attendance is not found and if the rules and regulations of the university is crossed, those students are not eligible to attend the final examination.
- 6. If the students fails to complete the project/seminar for internal evaluation in fixed date, those students are not eligible to attend the final examination.

9. Method of Study

- a. Professor will be given complete liberty related to teaching method, reference text and internal evaluation.
- b. It is compulsory and Inevitable for students to view the reference works along with prescribed syllabus text books related to the study subject and it is alson compulsory to complete the works related to the subject.
- c. It is compulsory and inevitable for students to participate in all the music programs, concerts, workshops special lectures, meeting the music artists for the purpose of study and visiting historical places and educational tours arranged from the university or department of music and dance academy and other institutions/associations. Special leave privilege will be given to the faculty accompanying students.
- d. Maximum 15 days and minimum 10 days leave is provided to the Professors and students participating in music program, concerts and seminars conducted by different university, art academies and different institutions inside and outside the state. The permission of registrar/study centre director through need of the department is compulsory. Participated program documents should be compulsorily submitted.

10. Examination method.

- 9. The examinations of three years B.music degree are conducted by two methods. i.e. internal evaluation and examination evaluation. Each paper carries 40 marks for internals and 60 for the paper. Students should pass in both the examinations.
- 10. The failed students will be given permission for re-examination consecutively for three times. If he fails even after, he will be given permission to appear for examination according to new syllabus.
- 11. Grace marks: One grace mark facility for each paper is provided. The required grace marks for passing will be allotted. This work will be executed by the examination committee president.

11. Internal evaluation process.

- a. The students must submit the practical and assignment to the subject professor and get it signed within the time limit fixed and must submit all the practical assignments to the head of the department for internal evaluation before the annual examination.
- b. B.Music final year degree students must submit 3 copies of minimum 25 pages dissertation for evaluation. There will be 80 marks for this paper and 20 for oral examination.
- c. Oral examination will be conducted on the date fixed by professor and head of the department and internal marks will be submitted to the university.
- d. Disciplinary action will be taken on the examiners on the circumstances of malpractices related to question paper, group copy and exceeding the limits of examination rules. Action will be taken on the head examiner and custodian of the examination centre by the

university according to the examination norms. Actions will be taken on the basis of the committee appointed by honorable vice-chancellor.

12. Study Board and examination board.

- a. Study Board and examination board will execute the work according to the rules of Kannada University.
- b. The professors attending the examination works of any exams conducted form study board and examination board will be provided with leave facility according to the University rules.

13. Convocation Certificate:

The Students passing B.music final year or any degree must pay the fees fixed by the university and may collect the convocation certificate.

14. Marks Card:

- a. The marks card given by the university will be in the medium of Kannada and English.
- b. Final year degree marks card with passing certificate (Kannada and English) will be given.
- c. The students losing original marks card in need of duplicate marks card must submit the necessary documents to the university by paying Rs. 500.00 fees to the university can collect the marks card.
- d. The students must pay rupees 100 to the Kannada University for minimum more than two amendment in the marks card.
- e. If there is need for one time amendment in the marks card, has to provide the necessary documents written 6 months of the announcement of the examination results.

15. Fee

The students have to pay the fee fixed by the university with the period.

16. Finance:

All the financial transaction of the university will by in the name of 'Finance Officer, Kannada University, Hampi, Vidyaranya-583 276, Hospete taluk, Bellary District.

17. Time table of academicals year.

- a. Application for admission starts from June 15.
- b. Commencement of classes July 15.
- c. The last date of admission for students is August 16.
- d. The last date for admission with fine August 31.
- e. The last date registration of the students in the University is September 30.
- f. Mid-term holidays from November 2 to 29.
- g. The commencement of lasses for the second term is on November 30.
- h. Examination fee should be paid between December 04 and 31.
- i. The last date to paying examination fees with fine is January 16.
- j. The last date for internal evaluation process is March 31.
- k. The students attendance list should be submitted to the university on April 1.
- 1. Period of academical year will be completed on April 15.
- m. Final examination begins on the months of April.
- n. Evaluation process begins after a week of completion 6 final examination.
- o. Announcement of results will be in the months of June.
- p. Academical year stars on June 15.

Notice: In case of Uncertainties or other reason if the above mentioned dates are announced as holidays by the University and if the dates are altered, it has to be followed. The academical activities follow accordingly.
